# Guidelines for Authors

## Aims and scope

The Oral Health and Dental Management in the Black Sea Countries journal tackles the field of oral health and dental management in the Black Sea Countries, aiming at disseminating specific knowledge to the large audience, by publishing scientific surveys, original studies and proceedings of the congress of the same name.

The scope of the journal comprises aspects of oral health looked upon through the light of preventive, pediatric, community, geriatric dentistry, orthodontics, oral pathology, TMJ disorders, implantology, oral health education, diet-hygienic regimen for promotion of orodental health as well as issues of management of dental surgery and nationwide dental managerial policies.

The journal seeks to consolidate the field of oral health and dental management in the Black Sea Countries, it being the first and the only profile journal in the area. It encourages contributing manuscripts which present methodologically detailed scientific research findings from original data collection or analysis of existing databases. Preference is given to new findings.

The journal is oriented towards all professionals in the field of oral health and dental management, faculty staff and likewise dentists, medical students, etc. The journal is published quarterly.

## Guidelines to authors

The requirements for submission are in accordance with the "Uniform Requirements for Manuscripts Submitted to Biomedical Journals", available at: <http://www.icmje.org/>

The following categories of contributions will be considered for publication:

1. Reports of original research
2. Original clinical observations accompanied by analysis and discussion
3. Analysis of management aspects of the biomedical sciences and health professions
4. Statistical compilations
5. Descriptions of evaluation of methods or procedures related to therapy or materials
6. Case reports with discussions

Manuscripts, **written in English**, should be submitted in **double-space typing**, Times New Roman 12 format, and sent **by e-mail** (as Microsoft Word attachments and the illustrations as JPEG files) or **by post** (please send one printed copy on A4 paper, together with the corresponding computer disk).

Articles should be arranged in the following order: *Title page, Statement Page, Summary, Introduction, Materials and Methods, Results, Discussions, Conclusions, Acknowledgements, References, Tables and Legends to illustrations*. **Each chapter will begin on a separate sheet. All pages will be numbered, beginning with the Title Page.** The maximum length of the manuscript, including tables and illustrations should not exceed 20 pages.

Authors are urged to write as concisely as possible, and to consult the references of Statement Page.

## Important general aspects

**Statement page.** Will be sent **by post** and include the following:

- name, postal address, telephone, fax and e-mail of the corresponding author;
- a statement that all authors have contributed to, and read the paper and have given permission for their name to be included as a co-author;
- a statement confirming that the manuscript has not been published and will not be submitted simultaneously or published elsewhere; if any illustrations, tables or other excerpts are included from copyrighted works, the source must be given in full, and written permission must be obtained from the respective author and publisher;
- articles involving clinical research should conform to the guidelines issued in the Declaration of Helsinki where applicable, and should receive ethical approval from the relevant committee. Patient identity must be hidden, in pictures as well as in text.
- own responsibility statements of conflicts of interests;
- signed informed consent of patients taking part in the study;
- statements must be signed by all authors.

**Editorial rights.** Article publishing is conditioned on accepting the right of the Editor to modify the text, with a view to improving clarity and style, or reducing it to length availabilities.

**Proofs.** Proofs will be sent to the corresponding authors (first authors if no correspondent author is identified), **by e-mail**, who must return their corrections within 48 hours of receipt. Any queries should be answered in full. It is important to ensure that all your corrections are returned to the Editor in one all-inclusive e-mail, as subsequent additional corrections will not be possible.

**Editorial process and acceptance.** Every submission will be acknowledged, by e-mail where possible. All manuscripts are peer-reviewed. Authors will be informed about the decision of acceptance for publication within maximum 2 months from receipt. In case of acceptance, the Editor will estimate the issue

in which the manuscript will be published. However, due to the use of international referees, the evaluation may last for more than two months, and we appeal to authors' understanding in such circumstances.

**Color printing.** Authors will be charged for the publication of color illustrations. They are advised to consult the Editor in advance. If the manuscript is accepted for publication, the Publisher will provide information regarding cost estimate.

## Article structure

**Title page.** Should contain the following information:

- Title of paper;
- Names, scientific/academic titles, postal address of all authors;
- Name, postal address, telephone, fax, e-mail of the corresponding author;
- To facilitate anonymity, the authors' names and any reference to their addresses should only appear on the title page.

**Summary page.** It should not exceed 250 words and should be presented under the following subheadings: *Objectives, Methods, Results, Conclusions* (for reviews: *Objectives, Data, Sources, Study selection, Conclusions*). 3-5 **key-words** should be added at the end of the summary. Please repeat the title of the article at the top of the summary page.

**Introduction.** Must be presented in a structured format, covering the following subjects, not necessarily under subheadings: succinct statement of the issue tackled; the essence of existing knowledge and understanding of the issue; the aims and objectives of the research being reported.

**Abbreviations and acronyms.** The names and terms to be referred to in the form of abbreviations and acronyms must be first mentioned in full. Use only standard abbreviations.

**Units of measurement.** SI units should be used. If non-SI units must be quoted, the SI equivalents should immediately follow between brackets.

*Teeth* should be mentioned in text with the complete names. In tables, illustrations or legends, teeth should be identified using the FDI two-digit system. Mention the statistical methods used; identify drugs, chemicals and technical equipment used by generic name (if trademarks are mentioned, manufacturer name, the city and country must be given).

**Illustrations.** Should be supplied as glossy photographic **prints**, high-resolution laser **prints** or **electronic** JPEG files.

Images should be of high quality; lettering and symbols should be of sufficient size to permit reproduction without loss of detail. Authors are to know that the majority of illustrations will be reduced to the width of a single column (approximately 85 mm). They are requested to express their wish in case illustrations are to be enlarged.

Pictures **on paper** will be clearly labeled on the back with the title of the article, the figure number and an arrow indicating the top edge.

For *radiographs, scanned images, other radiodiagnosis images or light and electron microscope images* send black and white or color glossy prints. Microscopic images must mention on the back the scale and staining used.

All illustrations should be mentioned in the text, between brackets and numbered consecutively. Each picture will be accompanied by a title and, if necessary, by additional information written in the legend page.

**Tables.** Each should be typed on a separate sheet, at double space, and numbered consecutively as they appear in the text. Explanatory notes are written under the table, together with the complete names of abbreviated terms. The following symbols will be used, in order: \*,†,‡,§,||,¶,\*\*,††,‡‡

**Illustration legend.** Should be typed at double spacing, with Arabic numerals corresponding to illustrations. When symbols, arrows, numbers, or letters are used to identify parts of the illustrations, identify and explain each one clearly in the legend. Explain the internal scale and identify the method of staining in photomicrographs.

**References.** They should be mentioned in the text, under *square* parentheses, in numerical order. The Vancouver style should be followed: <http://www.icmje.org/index.html#reference>. Please consider that the **style** of the *Oral health and Dental Management in the Black Sea Countries* journal includes:

- writing the full name of the journal;
- putting the journal/book title in italics;
- putting the journal volume in bold;
- putting the journal issue under brackets.

If references related to unpublished manuscripts and books are cited, the term "in press" should be mentioned under parentheses.

**The authors are responsible for the accuracy of the reference list at the end of the manuscript.**
